be postmarked by September 22, 2023, and received by Sponsor no later than September 30, 2023. Sponsor is not responsible for any mail not received by this date. There is a limit of only one (1) online or postcard entry per eligible entrant during the Entry Period; if multiple online entries and/or postcards are received on the same day for the same entrant, then only one (1) will be entered and the others will be discarded. Entries are not transferable or assignable. Automated entries are prohibited, and any use of automated devices will cause disqualification.
